

**DISNEY CRUISE LINE® PRESENTS: CATCH STITCH! SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN.**

**A PURCHASE OR PAYMENT WILL NOT  
INCREASE AN ENTRANT’S CHANCES OF WINNING.**

1. **Eligibility:** The Disney Cruise Line® Presents: Catch Stitch! Sweepstakes ("Sweepstakes") is only open to entrants, who at the time of entry are: (a) natural persons who are legal residents of, and currently living in, one of the 50 United States or the District of Columbia, or Canada (excluding Quebec); and (b) 18 years of age or older. Officers, directors, and employees (and members of their household or immediate family, *i.e.*, parents, children, spouse, siblings, grandparents, the "steps" of each and persons residing in such immediate family members' household) of Sponsor, Administrator, and each of their respective parent, related, affiliated and subsidiary companies, their advertising, promotion and web design agencies, all other entities involved in the creation, administration, or fulfillment of the Sweepstakes and their respective successors and assigns are not eligible to enter or win. Participation constitutes entrant's full and unconditional agreement to these official rules ("Official Rules") and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. 4. **Timing:** The Sweepstakes begins at 12:00:00 P.M. (noon) Eastern Time ("ET") on May 28, 2013 and ends at 11:59:59 P.M. ET on August 31, 2013 ("Sweepstakes Period"). Sponsor's computer will be the official clock for this Sweepstakes.
5. **How to Enter:** During the Sweepstakes Period, an eligible entrant ("Entrant") may register on-line by going to [www.CatchStitchSweepstakes.com](http://www.CatchStitchSweepstakes.com) (the "Website") and entering his/her valid e-mail address. If the Entrant is logging on to the Website for the first time, he/she will then be taken to a registration page where the Entrant must complete all of the requested information, including without limitation, complete name (no initials), zip or postal code, telephone number, and date of birth. Normal Internet access and usage charges imposed by your online service provider will apply. Data rates may apply to any entry via a Mobile Device. Entrant should check his/her wireless provider's customer pricing plan as carrier specific charges for mobile usage may apply. Entrants are solely responsible for any such wireless charges. Not all wireless carriers participate.

By completing and submitting the registration page, each Entrant will receive one (1) entry into the Sweepstakes ("Entry"). Each day during the Sweepstakes Period that an Entrant visits the Website and enters his/her e-mail address, the Entrant will receive one (1) additional Entry into the Sweepstakes. Each Entrant is limited to a maximum of one (1) Entry into the Sweepstakes per day, except as allowed for below (regardless of whether an Entrant has more than one e-mail address, and regardless of whether more than one person use the same e-mail address). A "day" is defined as starting at 12:00 A.M. ET and ending at 11:59:59 P.M. ET on a calendar day, except on May 28, 2013, when the day starts at 12:00 P.M. ET and ends at 11:59:59 P.M. ET. Entrants will not be allowed to change their physical address or e-mail address.

An Entrant may obtain up to six (6) additional Entries (individually, "Bonus Entry" and collectively, "Bonus Entries") during the Sweepstakes Period by investigating clues available on the Website and submitting an answer as to where Stitch is hiding. Limit one (1) answer per day. If an Entrant provided the correct answer, he/she will receive one (1) Bonus Entry. Correct answers will be displayed the following day on the Website. An Entrant may return to the Website each day during the Sweepstakes Period to submit an answer. There is a maximum limit of one (1) Bonus Entry per day for a total of six (6) Bonus Entries during the Sweepstakes Period. Once an Entrant has earned all six (6) available Bonus Entries, notice will be posted to the Website.

Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different e-mail addresses, identities, registrations and logins, or any other methods will void the Entrant's entries and that Entrant will be disqualified in the sole discretion of Sponsor. Any use of any micro, robotic, automatic, programmed, or like entry methods will void all such entries affected by such methods and Entrants using such methods will be disqualified. 6. **Grand Prize Winner Selection:** The odds of winning the Grand Prize depend upon the number of eligible entries received during the Sweepstakes Period. Administrator is an independent judging organization whose decisions, along with the Sponsor's, as to the administration and operation of the Sweepstakes and the selection of the potential Grand Prize are final and binding in all matters related to the Sweepstakes. Administrator will randomly select one (1) potential Grand Prize Winner from all eligible entries during the Sweepstakes Period, on or around September 3, 2013. The selected winner is deemed a potential winner pending verification of the winner's eligibility and compliance with the Official Rules. The potential Grand Prize Winner will be notified by e-mail and/or telephone on or about September 9, 2013. If the potential Grand Prize Winner cannot be contacted within five (5) business days from the date the potential Grand Prize Winner is notified, fails to execute and return all documentation within the required time, fails to pass a skill test (Canadian residents only – see Section 9 for more details), is found to be ineligible or is non-compliant with the Official Rules for any reason, then the potential Grand Prize Winner forfeits the Grand Prize and Sponsor may select another potential Grand Prize Winner. 7. **The Grand Prize (1) and Approximate Retail Value ("ARV"):** The Grand Prize is a 7-Night Disney Cruise Line Vacation to the Grand Prize Winner's choice of either the Eastern or Western Caribbean from Port Canaveral, Florida for four (4) persons aboard the *Disney Fantasy* ("Cruise"). The 7-Night Cruise shall consist of the following:
  - a. Four (4) roundtrip coach fares between the major gateway airport closest to the Grand Prize Winner's residence and Orlando International Airport, if the Grand Prize Winner resides outside a 200 mile radius of Orlando, FL. If the Grand Prize Winner lives within a two hundred (200) mile radius of Orlando, FL, the Grand Prize Winner must arrange for ground transportation to the Ship's Homeport from the Grand Prize Winner's home for

- the Grand Prize Winner and his/her guests and the Sponsor will reimburse the Grand Prize Winner for the reasonable cost of such ground transportation, up to \$200 USD.
- b. Roundtrip ground transportation from Orlando International Airport to the ship's Homeport.
  - c. A seven (7) night Eastern Caribbean Cruise or Western Caribbean Cruise on the *Disney Fantasy* leaving from Port Canaveral, Florida for four (4) persons and includes:
    - i. One (1) stateroom aboard the *Disney Fantasy*. Maximum occupancy four (4) people.
    - ii. All meals onboard the Cruise ship (with the exception of *Palo* and *Remy Fine Dining*).
    - iii. Pre-paid gratuities, Government Taxes and Fees (as defined on the Disney Cruise Line website at <http://disneycruise.disney.go.com/>).

The ARV of the Cruise is \$10,588.48 USD/ \$10,652.01CAD, which includes Government Taxes and Fees.

The following conditions apply:

1. Cruise must be booked at least 45 days prior to the intended travel dates and must be taken prior to September 30, 2014. Please see the Vacation Dates outlined in the Travel Planning section of the Disney Cruise Vacation brochure.
2. Vacation is for the Grand Prize Winner and up to three (3) "Guests" of the Grand Prize Winner's choosing.
3. Minors under the age of 18 not traveling with a parent or legal guardian must be accompanied by an adult over the age of 21 in the same stateroom. The parent or guardian of any minor not traveling with a parent or guardian must appoint an adult to have custody and control over their minor and to contract on their behalf in connection with the Disney Cruise Line vacation. An appointment form will be included in the document package and must be signed by parent or legal guardian prior to embarkation at the Disney Cruise Line terminal.

Grand Prize Winner and all Guests must travel together on specified itinerary. All travel dates and arrangements are subject to change based on availability and providers approval. Any portion of a Grand Prize not accepted by Grand Prize Winner will be forfeited.

Please note:

Changes to reservations, once made, are not permitted. A per ticket surcharge will apply for paper tickets issued in markets where electronic ticketing is available. Substitutions will not be allowed. Should the Grand Prize Winner elect to travel with fewer than three (3) Guests, no additional compensation will be provided.

8. **Limitations on Liability:** Entrants agree that Sponsor, Administrator, and their respective parents, subsidiaries and affiliated companies, advertising and promotion agencies, and all of their respective officers, directors, employees, representatives and agents (collectively "Released Parties") will have no liability whatsoever, and shall be held harmless by Entrants or any other participants in the Sweepstakes, for any injuries, claims, losses or damages of any kind to persons, including death, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of the Grand Prize or participation in this Sweepstakes, or Entrant's failure to comply with the Official Rules. The Released Parties shall not be liable to the Grand Prize Winner or any other person for failure to supply any prize(s) or

any part thereof, by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not the action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, terrorist acts, earthquake, war, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, or any other cause beyond the Released Parties' control. The Released Parties are not responsible for illegible, lost, late, damaged, incomplete, misdirected, or stolen entries; or for typographical or other errors in the offer or administration of this Sweepstakes, including but not limited to: errors in advertising, these Official Rules, selection and announcement of the Grand Prize and fulfillment of the Grand Prize; or for lost, interrupted or unavailable network, server, satellite, Internet Service Provider (ISP), website or other connections, availability or accessibility; or for miscommunications, failed computer, telephone or cable transmissions, lines, or technical failure; or jumbled, corrupted, scrambled, delayed, or misdirected transmissions, computer hardware or software malfunctions, failures or difficulties; or for any other errors of any kind whether human, mechanical, electronic, technical or network; or for the incorrect or inaccurate capture of entry or other information or the failure to capture any such information; or for any misdirection or delay of any e-mail to be received on account of technical problems or traffic congestion on the Internet/Website, or any combination thereof, including any injury or damage to Entrant's or any other person's computer related to or resulting from participation in or downloading or uploading any materials in connection with the Sweepstakes; or for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes; or for any personal injury, death, or damage to or loss of property, arising out of receipt or use or misuse of any the Grand Prize or any element thereof.

Sponsor may also disqualify any person that acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person or for any other good cause reason solely determined by Sponsor. Should any portion of the Sweepstakes be, in Sponsor's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of entries, Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Sweepstakes, and select the Grand Prize Winner from entries received prior to action taken or as otherwise deemed fair and appropriate by Sponsor. In the event of a dispute regarding Grand Prize claims or entries received from multiple users having the same e-mail address, the authorized subscriber of the e-mail address at the time of entry used to enter, and not the name on the registration form, will be deemed to be the Entrant and must comply with these Official Rules. Authorized account subscriber is the natural person who is assigned the address by the Internet Service Provider (ISP), on-line service provider, or other organization responsible for assigning e-mail addresses.

If the potential Grand Prize Winner is from Canada he/she will be required to correctly answer a time-limited skill testing question without any assistance in order to be eligible to receive the Grand Prize or the Grand Prize will be forfeited.

If any Grand Prize notification is returned as non-deliverable, the Grand Prize will be forfeited and an alternate Grand Prize Winner may be selected as further described in these Official Rules. Noncompliance with any of the foregoing or any portion of these Official Rules may result in disqualification and awarding of the Grand Prize to an alternate Grand Prize Winner. **Federal, state, provincial, territorial, and local taxes and all other expenses not specified herein are the Grand Prize Winner's sole responsibility.** The Sponsor may assign all rights granted by Entrants and the Grand Prize Winner hereunder to any party at Sponsor's sole discretion.

- 10. Disputes/Choice of Law:** The terms of this Sweepstakes shall be governed by, construed under, interpreted and enforced in accordance with the laws of the State of Florida. Any dispute or claim arising out of or in connection with this Sweepstakes or these Rules shall be submitted exclusively to the Circuit Court in and for Orange County, Florida, U.S.A. (or if the Circuit Court shall not have jurisdiction over the subject matter thereof, then to such other court sitting in such county having subject matter jurisdiction) for trial and determination by the court sitting without a jury. All Entrants consent to the jurisdiction of such court and to the service of process outside the State of Florida, U.S.A. pursuant to the requirements of such court in any matter submitted to it, and they expressly waive the right to a jury trial. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ANY CLAIM MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION ACCRUED, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.
- 11. Privacy:** Information collected from entrants is subject to the Sponsor's and Administrator's Privacy Policies.
